Kids Art Program Rules:

- When child arrives, he/she will check in with his/her Group Leader (assigned on the first day). A child will leave the program area only in the company of someone authorized to pick him/her up. The "authorized" pick-up person will go to the Group Leader to check out the child. List "authorized" names on the Registration Form.
- Children must be signed in and out each day by a parent or guardian. We understand that occasionally things go wrong, so if you realize that you will be late in picking up your child, please call the Nigra Arts Center at (518)661-9932 to alert our staff. This will allow staff to reassure children and prevent unnecessary worry.
- Please do not send your child to the program with cell phones or other electronic devices. Children are allowed to bring cell phones designated for emergency use only, but will be asked to keep them off during scheduled program sessions.
- Children will need to bring a lunch, water bottle and a snack each day. Lunches will be not be refrigerated but microwaves are available for warm ups. Please take this into consideration when packing lunches.
- We recommend that children wear shoes and clothing suitable for outdoor activities. Please remember that we are an Arts Center, so our programs can get messy!
- All children are expected to show respect to other children, staff, group leaders, and session leaders and cooperate fully with instructions.

- All children are expected to communicate in appropriate manner. Do not use foul language or gestures, harsh words or tone of voice.
- Nigra Arts Center staff are always here to answer questions about our kids art programs. If you have questions, comments or concerns, please contact our director, Maria Nestle, at (518)661-9932.
- Horseplay, unwelcome teasing or deliberately causing bodily harm are not acceptable and will not be tolerated. We have a zero tolerance bullying policy.
- All children are expected to use program equipment, supplies, and facilities properly. Children will be fully responsible for their actions and understand that irresponsible behavior will result in disciplinary action.
- All children are expected to abide by regulations made known by the Paul Nigra Center for Creative Arts.

Disciplinary Policy:

- For the benefit of all children, it is important that they behave appropriately. The following progressive steps are taken in the event of discipline concerns:
 - 1. The child will receive a verbal warning and a reminder about program rules.
 - 2. The child will be asked to leave the area and will speak to the program director about the consequences of their actions and they will together contact parent/guardian.
 - 3. The parent/guardian of the child will be contacted and the child will not be allowed to return to the program. No refunds will be issued if a child is asked to leave.
